We are allotting 30 to 35 minutes of the meeting of the Fisheries and Wildlife Section of the Michigan Academy of Science, Arts, and Letters to a panel discussion of the proposed Kirtland Warbler Preserve. The title of the discussion is "The Kirtland Warbler Preserve, An Insurance Plan for Michigan's "Jack-Pine Warbler." On the panel with you will be John Byelich, our district game supervisor from Mio, and Glen Schaap, in charge of state forest administration.

We will expect you to open the subject, outline the problem, and propose the method of attack, using whatever slides, charts, maps, will be helpful. The others will discuss the relation of the proposal to forestry and game management, and assess the practical aspects of carrying out Kirtland Warbler management.
